BSPlink users are reminded not to share their passwords. Sharing account credentials can put organizational security at risk by exposing customer information and financial data to unauthorized users.

Also, use strong passwords, and remember they need to be unique in every system and changed on a regular basis.

#### **BSPlink: TIP - Enhancements - Reports configuration**

The rest of the enhancements not released on July 2019 and related with the Global Consent Management have been released allowing the update of multiple consents at once, terminated consents visibility update or updates in the view of Global Consent Management options.

# **BSPlink: TIP - Termination of consents if airline is terminated**

The TIP options have been modified to consider active airlines those that still are active in the airline master table, even if their BSPlink user is currently not active. The queries will display the consents of all the active airlines, including those that do not have any active BSPlink user.

## Enabling CCEP, CCVA & CCAC form of payment types in WEBLink and NDCLink

Following the introduction of new forms of payment in BSP WEBlink and NDClink will be adapted to accept EP and CCEP as valid form of payments when reported inside the RET files submitted to any of these systems.

#### **Rejected document query enhancements**

An enhanced functionality has been added to the BSPlink's Rejected Documents query when loading Rejected Master Table from iBSP and Maestro in order to display and filter correctly the rejections with values R (Rejected) and W(Warning).

#### **BSPlink: TIP - Enhancements - Consent Management Changes**

Some enhancements not released on July 2019 will be released in August 2019. These enhancements include additional changes in the Global Consent Management such as allowing the update of multiple consents at once, terminated consents visibility update or updates in the view of Global Consent Management options.

#### **TIP - Forms of payment CCAC and CCVA**

In order to comply with DISH 23 specifications, the payments made with the Virtual Account Numbers (VAN) enrolled with IATA as an Alternative Transfer Method and the payments made with the agents own cards will be identified as CCAV and CCAC respectively.
