#### Reminder: BSPlink Credentials

BSP*link* users are reminded not to share their passwords. Sharing account credentials can put organizational security at risk by exposing customer information and financial data to unauthorized users.

Also, use strong passwords, and remember they need to be unique in every system and changed on a regular basis.

Lastly, please remember that you can use the "Forgotten Password?" link in the BSP*link* home page to reset and reinforce your credentials.



#### Developments to be released

#### **Annual Accumulated option improvements**

Two improvements have been brought to the airlines' 'Annual Accumulated' option: a date picker and financial values in graphic format, to help the user easily identify the figures and differences between domestic and international sales, as well as their own, compared to that of the industry.

#### **Future Developments**

#### **Delete Files and Delete Files Query options**

This new functionality will allow users to delete a file they have uploaded (already present in the user's container) as well as query the deleted files.

The two options ('Delete Files' and 'Delete Files Query') will be available for the Airline, BSP, DPC, Third Party, HOMU and MCMU users, under the 'FILES' module.

#### **Payment Card Acceptance module**

A new BSP*link* module called 'Card Acceptance' will be added, for the users to query and modify the acceptance of payment cards (or merchant agreements, if applicable).

## TIP (Transparency in Payments) – MVP Enhancements

New parameters will be added for the airline users, allowing them to define (either locally or globally) if they accept or reject the products added, as well as modifications to the permissions.

The airlines will also have a new query to retrieve the complete list of the providers and products available, with their corresponding data (permissions) and a query for historical permissions (terminated).

The main users who have sub-users will be able to configure the type of access, Read-only or Read-write, the sub-users will have to the new TIP options.

The airline users will also have a new email alert which they can configure to be informed of changes in products in the BSP.

# **Commission Control Query and Self-service update**

With these new options, airlines will be able to define, update and query the setups of their commission controls and the transmittal of that information to other related BSP*link* users (agents, BSP, GDS, DPC). Also, Agents and GDS will have a Commission Control email alert in case changes are performed by the Airline.

#### **TIP Reports configuration**

A new option called 'TIP Reports' will allow the selection of the TIP files the user can receive in BSP*link*.
