Developments for Release on Tuesday, 26th November 2013

Refund Application - Tax Fields

The online BSPlink Refund Notice and Refund Application will be modified in order to allow the user to dynamically enter as many taxes as needed. The behavior will be exactly the same as in the current VMPD form.

Furthermore, the printable BSPlink refund forms will take into account the number of taxes to be displayed. The size and placing of the taxes will be adapted to the available space in order to ensure the printing of the document in a single page whenever possible.

Carrier Identification Plate (CIP) and Ticket Service Provider (TSP) Master Files

A header and footer has been added to the daily CIP and TSP master files addressed to the DPC recipient.

EMD / Weblink RET Validation Update

The validation of the Weblink RET files will be updated in order to accept the values "Y" and blank in the EMCI field as follows:

If the TRNC field is equal to "EMDS", then the values accepted in the EMCI field are: "Y" or Blank; when the TRNC field is equal to "EMDA" then the EMCI field must always be blank.

ADM VISION Enhanced Dispute File

New improvement aimed for ADM Vision users so that more information (if configured by the user), can be included in the 'eh' file, i.e., ADM amount, dispute date and ticket number.

Change of IP Addresses

This is to inform you that **between 16th Dec 2013 and 16th Jan 2014**, the BSPlink Supplier, Accelya, will change all their public IP addresses.

These are the changes which will be implemented:

1. The sftp.accelya.com server will have a new IP address: 185.14.24.12.

- Users will have to update their connection scripts, if these scripts are still connecting directly to the IP address.
- Please make the change between 16th Dec 2013 and 16th Jan 2014.
- During this period, both IPs (current one - 85.118.246.162 and new one - 185.14.24.12) will be active.
- On 16th Jan 2014, the old IP address will be deactivated. As on previous occasions, a notification will be added in the BSPlink message center.

2. For BSPlink a new IP address will be used: 185.14.24.11. This new IP address will be associated with the www.bsplink.iata.org domain.
