#### **Developments Released**

#### FOP file by mail

A new option was created in BSPlink for GDS users, which allows them to configure email addresses to which the FOP file can be sent as an attachment. This option also allows GDS users to decide whether they continue receiving the Form of Payment file through SFTP and/or via email.

#### **Commission Control Query and Self-service update**

With these new options, airlines will be able to define, update and query the setups of their commission controls. This information will be also available to other related users (agents, BSP, GDS, and DPC) in BSPlink System. Agents and GDS users will have the possibility to set a Commission Control email alert to be notified in case any changes are performed by the Airline.

#### **Future Developments**

#### **GDS FOP file copy / Agents FOP information request**

GDSs will be able to request a copy of the GDS FOP file to be sent to the GDS BSPlink container of a chosen environment. Also, GDS users will be able to request agents FOP information for all agents or an agent of the environment where the user is logged.

## **NFE Self-learning Monitoring Tool**

BSPlink will display a series of pop-up messages to all BSPlink users when they connect in order to inform them about the upcoming new front-end.

### **Ticketing Authority Red Alert files**

A new parameter will be added in the requests for the Agent Deactivation Web Service to inform BSPlink of agent deactivations marked as urgent. When the Urgent parameter is received with values 'Yes', BSPlink will advance the generation of the corresponding Global GDS Ticketing Authority Files from their usual schedule.
